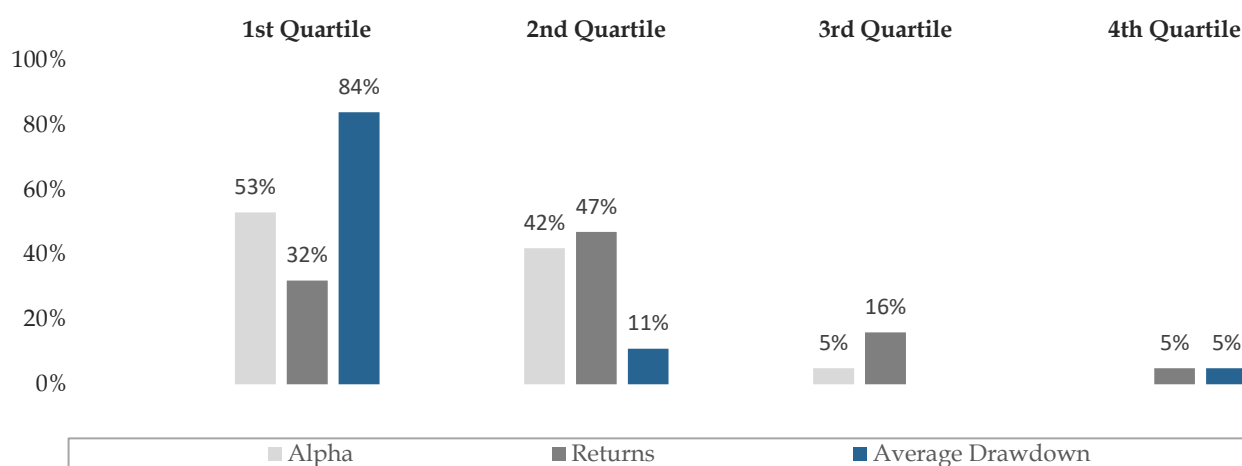


**STRATEGIC GROWTH, 4Q 2019**

**FIRM:** Mar Vista's purpose is to create value for our investors by generating unique risk-adjusted returns that exceed the opportunity cost of investing in a passive index. Our mission requires a conviction to be different in how we think, behave and invest.

**PHILOSOPHY:** We invest in high quality growth businesses trading at discounts to fair value. Specifically, we look for competitively advantaged companies with abundant opportunities to grow and reinvest capital at high rates of return. We also seek management teams with a proven ability to allocate capital in ways that maximize shareholder value.

**STRATEGY:** The Strategic Growth strategy seeks long-term capital appreciation by investing in a portfolio of 30-50 durable franchises that can grow excess returns on capital well into the future yet trade at attractive margins of safety. We believe the diversification found in a portfolio of 30-50 stocks provides ample opportunity for differentiated outcomes, while dampening the volatility inherent in more concentrated products.

**STRATEGIC GROWTH, 4Q 2019**
**Quarter Commentary:**

Equities registered strong fourth quarter performance and some of their best annual gains since 2009. Accommodative monetary policy and optimism around phase one of the US-China trade deal contributed to this year's record highs. Stock prices were bolstered by resilient economic activity and favorable financial conditions. The information technology sector led the market with a 48% gain thanks to substantial increases by Apple (+86%) and Microsoft (+55%). Their gains carry significant heft as the two largest publicly traded companies with market values in excess of \$1 trillion each. The fundamental backdrop of restrained inflation, low interest rates and moderate earnings growth continues to be favorable for asset price appreciation.

For the fourth quarter, Mar Vista's Strategic Growth strategy returned +7.6% net of fees, underperforming the Russell 1000® Growth Index (+10.6%) and the S&P 500® Index (+9.1%). Positive stock selection and relative outperformance in industrials and communication services combined with an underweight in consumer discretionary contributed to performance during the quarter, while information technology, healthcare, and materials diminished short-term results. Top contributors were Apple (+31.5%), First Republic Bank (+21.7%), Adobe (+19.4%), Alphabet (+9.7%) and Berkshire Hathaway (+8.9%), while Booking Holdings (-5.7%), Unilever (-3.7%), Oracle (-3.3%), Markel (-3.3%) and Ecolab (-2.3%) detracted from returns.

The portfolio's average discount to intrinsic value decreased to 1% this past quarter. With this narrow margin of safety, we expect future returns to correlate more with our companies' abilities to compound intrinsic value. Our elevated cash levels were reduced this quarter after the market presented us with new idiosyncratic opportunities. Investment bargains remain elusive, but stock price volatility has a way of sneaking up on markets. In an environment with growing optimism, we will remain diligent and patient in deploying capital within our wide-moat universe.

The composite is defined to include all fully discretionary portfolios with no minimum or maximum account value, managed in accordance with Mar Vista's Strategic Growth strategy, and that paid for execution on a transaction basis. Prior to 1/01/06, the composite was defined to include only taxable portfolios with no minimum or maximum value. The results in the column marked Net of Fees for the periods 8/01/08 through the present, include a standard management fee applied to any non-fee paying portfolio for performance calculation purposes.

The primary benchmark is the Russell 1000® Growth Index, defined as an unmanaged, capitalization weighted index of those Russell 1,000 companies with higher price-to-book ratios and higher forecasted growth values. Index returns include dividends and/or interest income and, unlike composite returns, do not reflect fees or expenses. In addition, unlike the composite, which periodically maintains a significant cash position, the Russell 1000® Growth Index is fully invested. Investors cannot directly invest in an index. The secondary benchmark is the S&P 500® Index, defined as an unmanaged, capitalization weighted index of the common stocks of 500 major U.S. corporations. Index returns include dividends and/or interest income and, unlike composite returns, do not reflect fees or expenses. In addition, unlike the composite, which periodically maintains a significant cash position, the S&P 500® Index is fully invested. Investors cannot directly invest in an index. The dispersion in composite returns shown herein was measured using an asset-weighted standard deviation formula.
