## Website Privacy Policy

### 1. Information We Collect

#### A. Information You Provide Voluntarily

We may collect personal information you voluntarily provide, including when you:

- Submit a contact form
- Communicate with us via email

This information may include:

- Name
- Email address
- Phone number
- Employer or company affiliation
- Any information you include in your message

We request that you do not transmit sensitive personal information (such as Social Security numbers or financial account numbers) through the website.

#### B. Information Collected Automatically

When you visit our Site, we may automatically collect certain information through cookies and similar technologies, including:

- IP address
- Browser type and version
- Device identifiers
- Operating system
- Pages visited
- Referring website
- Date and time of access
- Time spent on pages
- Clickstream data

This information helps us understand how visitors use our Site and improve functionality and performance.

### 2. Cookies and Tracking Technologies

We use cookies and similar tracking technologies to operate the Site and enhance user experience. Cookies are small data files stored on your device when you visit a website.

We may use:

- **Strictly Necessary Cookies** – required for basic website functionality
- **Performance and Analytics Cookies** – to understand site usage and improve performance
- **Third-Party Cookies** – provided by service providers such as analytics vendors

These technologies may collect internet or other electronic network activity information. We do not sell personal information collected through cookies. However, we may share information with analytics or service providers to help operate and improve the Site.

You may manage cookies through your browser settings. Disabling certain cookies may impact website functionality.

### **3. How We Use Information**

We may use information collected through the Site to:

- Respond to inquiries and requests
- Provide information about our services
- Maintain and improve the Site
- Monitor and analyze usage trends
- Protect the security and integrity of the Site
- Comply with legal and regulatory obligations

### **4. How We Share Information**

We may share information:

- With service providers who assist in operating the Site
- With professional advisers (legal, compliance, auditors)
- To comply with legal obligations, court orders, or regulatory requests
- To protect the rights, safety, or security of Mar Vista or others

We do not sell personal information collected through the Site.

### **5. Data Security**

We maintain reasonable administrative, technical, and physical safeguards designed to protect information collected through the Site from unauthorized access, disclosure, alteration, or destruction. However, no internet transmission is completely secure, and we cannot guarantee absolute security.
